1 Scope

This specification is developed to provide for the safe and functionally interchangeable rotating control devices (RCDs) used in air drilling, drilling operations for oil and gas, and in geothermal drilling operations.

Technical content provides requirements for design, performance, materials, testing and inspection, welding, marking, handling, storing, and shipping. This specification does not apply to field use or field-testing of RCDs.
