- (a) Classification has been rationalized to align with AS 1418.1—1986 on the basis of a minimum design life of 10 years.
- (b) Tables on combinations and values of loading have been aligned with AS 1418.1—1986.
- (c) Type test requirements have been consolidated.
- (d) Enclosure requirements have been upgraded.
- (e) Safety gear requirements have been clarified to align with current practice.
- (f) Definitions have been removed and are now incorporated in AS 2549.
- (g) Editorial changes including the following:
 - (i) Restructure of format.
 - (ii) Update of referenced Standards.
 - (iii) The term 'clause' has been substituted for 'rule' throughout the text.

CRANES (INCLUDING HOISTS AND WINCHES)

PART 7: BUILDERS' HOISTS AND EQUIPMENT

SECTION 1. SCOPE AND GENERAL

1.1 SCOPE. This Standard sets out requirements for hoists essentially for use in the building industry. It does not apply to tower cranes (AS 1418.4), mobile and vehicle loading cranes (AS 1418.5), mining hoists, equipment and chimney hoists, and elevating work platforms (AS 1418.10) of the rack and pinion, hydraulic or telescopic types.

1.2 APPLICATION. The hoists shall comply with the general requirements for design in Section 2 and the specific requirements in Section 3 for materials hoists and concrete skip hoists or in Section 4 for men and material hoists, according to the type of hoist. This Standard is complementary to AS 1418.1, but the requirements herein shall take precedence over corresponding requirements in that Standard.

1.4 DEFINITIONS. For the purpose of this standard the definitions given in AS 2549 apply.
