Preface

This Standard was prepared by the Standards Australia Committee ME-057, Road Tankers for Hazardous Liquids and Gases to supersede AS 2809.5—2001, *Road tank vehicles for dangerous goods, Part 5: Tankers for bitumen-based products*.

The objective of this document is to provide requirements for the design, construction, inspection and testing of road tank vehicles for the transport of ADG Class 3 and Class 9 bitumen-based products.

The major changes in this edition are as follows:

- (a) Issues common to all hazardous cargoes have been moved to AS 2809.1.
- (b) Issues pertaining to all flammable cargoes have been moved to AS 2809.2.
- (c) New information included for combustion cabin heaters.
- (d) New information included on stowage of hoses and other equipment.
- (e) A new section on heating systems replaces the previous Appendix A.

Section 1 Scope and general

1.1 Scope

This document specifies requirements for the design, construction, inspection and testing of road tank vehicles for the transport of ADG Class 3 and Class 9 bitumen-based products.

1.2 Application

Road tank vehicles for the transport of bitumen-based products shall conform to AS 2809.1. Where any requirement of this document differs from a similar requirement in AS 2809.1, this document shall take precedence.
