## PREFACE

This Standard was prepared by the Standards Australia Committee CS-005, Playground Equipment, to supersede, AS 4685.6—2004, *Playground equipment, Part 6: Particular safety requirements and test methods for rocking equipment*.

This Standard will apply from the date of publication. However, the Committee has decided that, to avoid excessive costs to manufacturers and operators, the superseded Standard AS 4685.6—2004, will continue as an alternative for a period of one year after the publication date.

The objective of this Standard is to specify particular safety requirements for rocking equipment greater than 0.5 m intended for permanent installation for use by children. General requirements and test methods are set out in AS 4685.1.

This Standard is identical with and has been reproduced from EN 1176-6:2008, *Playground equipment and surfacing, Part 6: Additional specific safety requirements and test methods for rocking equipment*.

As this Standard is reproduced from an International Standard, the following apply:

- (a) In the source text ‘this European Standard’ should read ‘this Australian Standard’.
- (b) A full point substitutes for a comma when referring to a decimal number.

References to International Standards should be replaced by references to Australian Standards, as follows:

This document is applicable to rocking equipment which is used as playground equipment for children as defined in 3.1. Where the main play function is not rocking, the relevant requirements in this document may be used, as appropriate.

This document specifies additional safety requirements for seesaws and rocking equipment intended for permanent installation for use by children.

It is intended to provide protection to the user against possible hazards during use.

NOTE Guidance for assessing the safety of other forms of seesaw/rocking equipment is given in Annex A.

**3 Terms and definitions**

For the purposes of this document, the terms and definitions given in EN 1176-1:2008 and the following apply.

**3.1****rocking equipment; seesaw (hereinafter referred to as equipment):**

equipment that can be set in motion by the user and is generally characterized by a rigid element that rocks about a central support

NOTE 1 The equipment can have one or several seats or stands.

NOTE 2 Figure 1a) shows the principle components for rocking equipment. Figure 1b) shows the principle components for seesaws.

NOTE 3 The seesaw/rocking movement depends on the type and configuration of fixture (see Figures 2 to 7).
