PREFACE

This Standard was prepared by the Standards Australia Committee IT-028, Electronic Animal Identification and Data Capture Systems. It has been reproduced from ISO 11784:1996, *Radio-frequency identification of animals—Code structure*, and some variations for Australian conditions have been included.

The objective of this Standard is to provide electronic identification device manufacturers and users with a national scheme for allocation and use of numbers for animal identification, the numbers being internationally unique to allow for international movement of animals.

Variations to ISO 11784:1996 for application to companion animals in Australia are listed in Appendix ZZ. The variations are indicated in the body of the Standard by a single marginal bar located next to the varied text.

The term ‘normative’ has been used in this Standard to define the application of an appendix to which it applies. A ‘normative’ appendix is an integral part of a Standard.

Statements expressed in mandatory terms in notes to tables are deemed to be requirements of this Standard.

As this Standard is reproduced from an International Standard, the following applies:

- (a) Its number does not appear on each page of text and its identity is shown only on the cover and title page.
- (b) In the source text ‘this International Standard’ should read ‘this Australian Standard’.
- (c) A full point should be substituted for a comma when referring to a decimal marker.

References to International Standards should be replaced by references to equivalent Australian Standards, as follows:
