PREFACE

This Standard was prepared by the Standards Australia Committee QR-005, Dependability.

The objective of this Standard is to provide guidance on the procedure for Failure Mode and Effects Analysis (FMEA) and Failure Mode, Effects and Criticality Analysis (FMECA) and give guidance on their applications, including the basic principles, procedural steps, terms, assumptions, criticality measures and failure modes, with examples. It is suitable for use in conjunction with the AS IEC 60300 series of dependability management Standards.

This Standard is identical with, and has been reproduced from IEC 60812 Ed. 2.0 (2006), *Analysis techniques for system reliability—Procedure for failure mode and effects analysis (FMEA)*, which is part of a suite of Standards developed by the IEC Technical Committee IEC/TC 56, Dependability.

As this Standard is reproduced from an International Standard, the following applies:

- (a) Its number does not appear on each page of text and its identity is shown only on the cover and title page.
- (b) In the source text ‘this International Standard’ should read ‘this Australian Standard’.
- (c) A full point should be substituted for a comma when referring to a decimal marker.

This International Standard describes Failure Mode and Effects Analysis (FMEA) and Failure Mode, Effects and Criticality Analysis (FMECA), and gives guidance as to how they may be applied to achieve various objectives by

- providing the procedural steps necessary to perform an analysis;
- identifying appropriate terms, assumptions, criticality measures, failure modes;
- defining basic principles;
- providing examples of the necessary worksheets or other tabular forms.

All the general qualitative considerations presented for FMEA will apply to FMECA, since the latter is an extension of the other.
