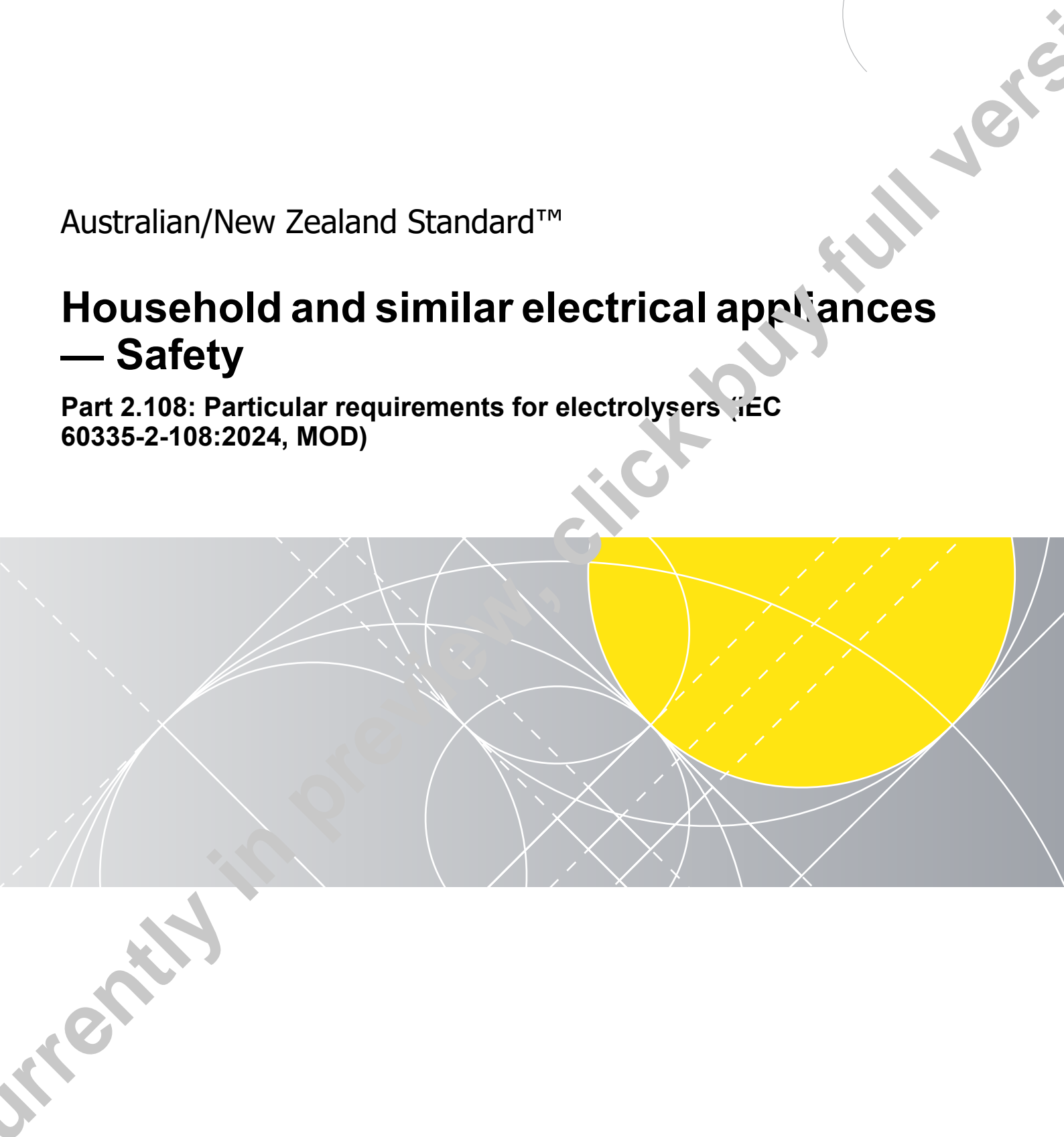

PREFACE

This standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL-002, *Safety of household and similar electrical appliances and small power transformers* to supersede AS/NZS 60335.2.108:2008 three years from the date of publication of this standard. During this period, AS/NZS 60335.2.108:2008 and its amendments will also remain current. Regulatory authorities that reference this standard in regulation may apply these requirements at a different time. Users of this standard should consult these authorities to confirm their requirements.

The objective of this standard is to provide manufacturers, designers, regulatory authorities, testing laboratories, and similar organisations with safety requirements designed to give the user protection against hazards that might occur during normal operation and abnormal operation of the appliance and which may be used as the basis for approval for sale or for connection to the electricity supply mains in Australia and New Zealand.

The text of IEC 60335-2-108, Ed. 2.0, prepared by IEC Technical TC 61, was submitted to the Standards Australia/Standards New Zealand Combined Procedure (dual public comment and committee vote) for adoption of the IEC standard as a Standards Australia/Standards New Zealand joint standard.

The principal changes in this edition as compared with the 2008 edition of AS/NZS 60335.2.108 are as follows (minor changes are not listed):

- (a) Alignment with AS/NZS 60335.1:2022;
- (b) Some notes have been converted to normative text (Clause 1, 22.012);
- (c) Application of test probe 19 has been introduced (subclauses 8.1.1, 20.2, B22.3, and B22.4);
- (d) Addition of external accessible surface temperatures (Clause 11).

This standard is an adoption with national modifications of the second edition of IEC 60335-2-108, *Household and similar electrical appliances – Safety – Part 2-108: Particular requirements for electrolyzers*. It has been varied as indicated to take account of Australian and New Zealand conditions.

This part 2 has to be used in conjunction with the latest edition of AS/NZS 60335.1 *Household and similar electrical appliances – Safety – Part 1: General requirements* and its Amendments, unless that edition precludes it; in that case, the latest edition that does not preclude it is used. It was established on the basis of AS/NZS 60335.1:2022.

This part 2 supplements or modifies the corresponding clauses of AS/NZS 60335.1 so as to convert it into the Australian/New Zealand Standard: Safety requirements for electrolyzers.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states 'addition', 'modification', or 'replacement', the relevant text of Part 1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, and so on;
- subclauses, notes and annexes that are additional to those in the IEC standard are prefixed with the letters AZ.

The essential safety requirements in AS/NZS 3820¹ that could be applicable to requirements for electrolysers are covered by this standard.

The national variations to IEC 60335-2-108, Ed. 2.0 form the Australian and New Zealand national variations for purposes of the IECEE scheme for recognition of results of testing to standards for safety of electrical equipment (the CB scheme).

The text of the international standard IEC 60335-2-108, Ed. 2.0 was approved as a joint Australia/New Zealand standard, noting the effect of national variations in AS/NZS 60335.1:2022.

INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

Guidance documents concerning the application of the safety requirements for appliances can be accessed via TC 61 supporting documents on the IEC website <https://www.iec.ch/tc61/supportingdocuments>

This information is given for the convenience of users of this International Standard and does not constitute a replacement for the normative text in this standard.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules can differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another part 2 of IEC 60335, the relevant part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal publications, basic safety publications and group safety publications covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards.

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

For **electrolysers**, testing in accordance with this standard is an option and cannot be required as a precondition for testing the complete appliance, for example by reference in Clause 24 of a part 2 of IEC 60335. Testing of the appliance may be reduced if an incorporated **electrolyser** including its protection system or control system, if any, complies with this standard.

In particular, the construction detail inspection and testing may be done separately on the **electrolysers**, thereby eliminating the need for inspection and testing when the **electrolysers** is applied to different appliances.

NOTE 3 Standards dealing with non-safety aspects of household appliances are:

- IEC standards published by TC 59 concerning methods of measuring performance;
- CISPR 11, CISPR 14-1 and relevant IEC 61000-3 series standards concerning electromagnetic emissions;
- CISPR 14-2 concerning electromagnetic immunity;
- IEC standards published by TC 111 concerning environmental matters.

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-108: Particular requirements for electrolysers

1 Scope

This clause of Part 1 is replaced by the following.

This part of IEC 60335 deals with the safety of **electrolysers** that produce low viscosity, ionized liquids intended for use as detergent free wash water in appliances for household and similar purposes and which conform with the standards applicable to such appliances. It applies to **electrolysers** tested separately, under the most severe conditions that can be expected to occur in normal use, their **rated voltage** being not more than 250 V including direct current (DC) supplied appliances and **battery-operated appliances**.

Examples of appliances that can contain **electrolysers** are

- dishwashers (IEC 60335-2-5);
- washing machines (IEC 60335-2-7);
- appliances producing wash water for hygiene purposes.

This standard does not supersede the requirements of standards relevant to the particular appliance in which the **electrolyser** is used. However, if the **electrolyser** used complies with this standard, the tests for the **electrolyser** specified in the particular appliance standard can be unnecessary in the particular appliance or assembly. If the **electrolyser** control system is associated with the particular appliance control system, additional tests can be necessary on the final appliance. Guidance for additional requirements to be considered for inclusion in the end product standards for appliances that use **electrolysers** is given in informative Annex BB.

Attention is drawn to the fact that

- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements can be necessary;
- in many countries, additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities and similar authorities.

This standard does not apply to

- appliances intended exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas).
