## PREFACE

This standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL-002, *Safety of household and similar electrical appliances and small power transformers* to supersede AS/NZS 60745.2.19:2011 three years from the date of publication of this standard. During this period, AS/NZS 60745.2.19:2011 will also remain current. Regulatory authorities that reference this standard in regulation may apply these requirements at a different time. Users of this standard should consult these authorities to confirm their requirements.

The objective of this standard is to provide manufacturers, designers, regulatory authorities, testing laboratories, and similar organisations with safety requirements designed to give the user protection against hazards that might occur during normal operation and abnormal operation of the appliance and which may be used as the basis for approval for sale or for connection to the electricity supply mains in Australia and New Zealand.

The text of IEC 62841-2-19, Ed. 1.0, prepared by IEC Technical Committee TC 116, was submitted to the Standards Australia/Standards New Zealand Combined Procedure (dual public comment and committee vote) for adoption of the IEC standard as a Standards Australia/Standards New Zealand joint standard.

This standard is an adoption with national modifications of the first edition of IEC 62841-2-19, *Electric motor-operated hand-held tools, transportable tools and lawn and garden machinery – Safety – Part 2-19: Particular requirements for hand-held jointers*. It has been varied as indicated to take account of Australian and New Zealand conditions.

This part of AS/NZS 62841 has to be used in conjunction with the latest edition of AS/NZS 62841.1, *Electric motor-operated hand-held tools, transportable tools and lawn and garden machinery – Safety – Part 1: General requirements* and its amendments. It was established on the basis of AS/NZS 62841.1:2015.

This part of AS/NZS 62841 supplements or modifies the corresponding clauses of AS/NZS 62841.1 so as to convert it into the Australian/New Zealand Standard: Safety requirements for hand-held jointers.

When a particular subclause of AS/NZS 62841.1 is not mentioned in this part of AS/NZS 62841, that subclause applies as far as is reasonable. When this standard states ‘addition’, ‘modification’, or ‘replacement’, the relevant text of AS/NZS 62841.1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in AS/NZS 62841.1;
- unless notes are in a new subclause or involve notes in AS/NZS 62841.1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, and so on;
- subclauses, notes and annexes that are additional to those in the IEC standard are prefixed with the letters AZ.

NOTE 2 The following print types are used:

- requirements: in roman type;
- test specifications: in italic type;
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3.

The text of the international standard IEC 62841-2-19, Ed. 1.0 was approved as a joint Australian/New Zealand standard, noting the effect of national variations in AS/NZS 62841.1:2015.

#### 3.101

#### **jointer**

**hand-held tool** equipped with a **disc cutter** intended to cut a slot or groove

Note 101 to entry: Examples of **jointer** designs are shown in Figure 101.

#### 3.102

#### **disc cutter**

rotating cutting **accessory** having its main feed direction perpendicular to its axis of rotation, for working in wood or similar material intended to cut a slot or groove through chip removing, cutting on its periphery and both flanks simultaneously

Note 101 to entry: The diameter of the **accessory** is much larger than its thickness.
