This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL-002 - Safety of Household and Similar Electrical Appliances and Small Power Transformers to supersede AS/NZS 62841.3.9:2015 three years from the date of publication of this Standard. During this period AS/NZS 62841.3.9:2015 will also remain current. Regulatory authorities that reference this Standard in regulation may apply these requirements at different time. Users of this Standard should consult with these authorities to confirm their requirements.

The objective of this Standard is to provide manufacturers, designers, regulatory authorities, testing laboratories and similar organizations with safety requirements designed to give the user protection against hazards that might occur during normal operation and abnormal operation of the appliance and which may be used as the basis for approval for sale or for connection to the electricity supply mains in Australia and New Zealand.

The text of IEC 62841-3-9 Ed 2, prepared by IEC Technical Committee TC 116, was submitted to the Standards Australia/Standards New Zealand Combined Procedure (dual public comment and committee vote) for adoption of the IEC standard as a Standards Australia/Standards New Zealand joint standard.

The principal changes in this edition as compared with the 2015 edition of AS/NZS 62841.3.9 are as follows (minor changes are not listed):

- Clause 1: Scope: increase of the maximum saw blade diameter to 410 mm;
- Corrigendum 1 and Corrigendum 2 of the IEC first edition have been incorporated in this edition.

This Standard is an adoption with national modifications of the second edition of IEC 62841-3-9 *Electric motor-operated hand-held tools, transportable tools and lawn and garden machinery – Safety – Part 3-9 Particular requirements for transportable mitre saws*. It has been varied as indicated to take account of Australian and New Zealand conditions.

This part 2 has to be used in conjunction with the latest edition of AS/NZS 62841.1 *Electric motor-operated hand-held tools, transportable tools and lawn and garden machinery – Safety – Part 1: General requirements and its Amendments*. It was established on the basis of AS/NZS 62841.1:2015.

This part 2 supplements or modifies the corresponding clauses of AS/NZS 62841.1 so as to convert it into the Australian/New Zealand Standard: Safety requirements for transportable mitre saws.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text of Part 1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.;
- figures, subclauses, notes and annexes that are additional to those in the IEC standard are prefixed with the letters AZ.

NOTE 2 The following print types are used:

- requirements: in roman type;
- *test specifications: in italic type;*
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3.

p NOTE 3 In this document, p is used in the margin to indicate instructions for preparing a consolidated version.

The essential safety requirements in AS/NZS 3820¹ that could be applicable to requirements for transportable mitre saws are covered by this standard.

The national variations to IEC 62841-3-9 Ed 2 form the Australian and New Zealand national variations for purposes of the IECEE scheme for recognition of results of testing to standards for safety of electrical equipment (the CB scheme).

1 Scope

This clause of Part 1 is applicable, except as follows:

Addition:

This part of IEC 62841 applies to transportable **mitre saws** intended to be used with a toothed saw blade for cutting wood and analogous materials, plastics and nonferrous metals except magnesium with a saw blade diameter not exceeding 410 mm, which hereinafter might simply be referred to as saw or tool.

This International Standard does not apply to **mitre saws** intended to cut other metals, such as magnesium, steel and iron. This document does not apply to **mitre saws** with an automatic feeding device.

NOTE 101 Transportable saws intended to cut ferrous metals will be covered by a future part of IEC 62841-3.

This document does not apply to saws designed for use with abrasive wheels.

NOTE 102 **Transportable tools** designed for use with abrasive wheels are covered by IEC 62841-3-10.

This document does not apply to tools combining the function of a **mitre saw** with the function of a table saw.

NOTE 103 **Transportable tools** combining the function of a **mitre saw** with the function of a table saw are covered by a future part of IEC 62841-3.

3.101

bevel angle

angular displacement of the saw blade plane with respect to the **table top** plane, the position of the saw blade plane that is perpendicular to the **table top** being the 0° bevel position

3.102

compound angle

angular displacement of the saw blade plane having a **bevel** and **mitre angle** other than 0°
