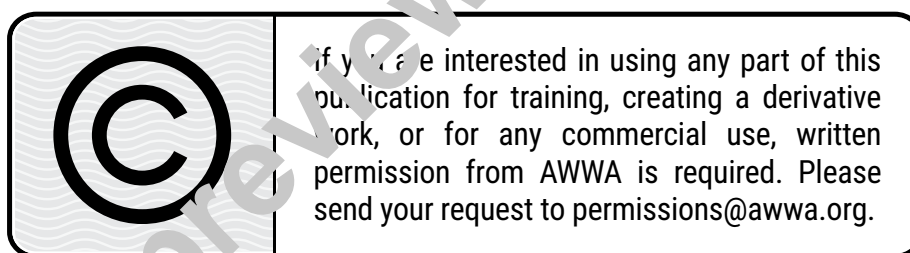
AWWA Standard
