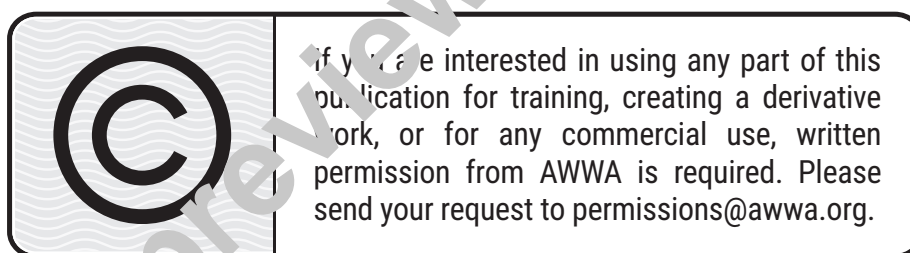
AWWA Standard
