# Preface

This is the third edition of the CSA A123.5, *Asphalt shingles made from glass felt and surfaced with mineral granules*. It supersedes the combined edition of CSA A123.1/A123.5, published in 2005 and 1998.

For this edition, the CSA A123.1 component has been removed.

This Standard provides a detailed sampling procedure integrated with the test methodology.

This Standard was prepared by the Technical Committee on Bituminous Roofing Materials, under the jurisdiction of the Strategic Steering Committee on Construction and Civil Infrastructure, and has been formally approved by the Technical Committee.

## Notes:

- 1) *Use of the singular does not exclude the plural (and vice versa) when the sense allows.*
- 2) *Although the intended primary application of this Standard is stated in its Scope, it is important to note that it remains the responsibility of the users of the Standard to judge its suitability for their particular purpose.*
- 3) *This Standard was developed by consensus, which is defined by CSA Policy governing standardization — Code of good practice for standardization as “substantial agreement. Consensus implies much more than a simple majority, but not necessarily unanimity”. It is consistent with this definition that a member may be included in the Technical Committee list and yet not be in full agreement with all clauses of this Standard.*
