Preface

This is the fourth edition of CSA C22.2 No. 232, *Optical fiber cables*. It supersedes the previous editions published in 2017, 2009, and 1988. It is one of a series of Standards issued by CSA Group under Part II of the *Canadian Electrical Code*.

The following are major changes to this edition:

- a) deletion of types OFNH and OFCH from Clauses [3](#), [6.1](#), and [7.1](#); and
- b) addition of FT6 criteria (See Clauses [6.1](#) and [7.1](#)).

For general information on the Standards of the *Canadian Electrical Code, Part II*, see the Preface for CAN/CSA-C22.2 No. 0.

This Standard is considered suitable for use for conformity assessment within the stated scope of the Standard.

This Standard was prepared by the Integrated Committee on Control, Instrument, Communication, and Marine Cables under the jurisdiction of the Technical Committee on Wiring Products and the Strategic Steering Committee on Requirements for Electrical Safety, and has been formally approved by the Technical Committee.

This Standard has been developed in compliance with Standards Council of Canada requirements for National Standards of Canada. It has been published as a National Standard of Canada by CSA Group.

Interpretations: The Strategic Steering Committee on Requirements for Electrical Safety has provided the following direction for the interpretation of standards under its jurisdiction: “The literal text shall be used in judging compliance of products with the safety requirements of this Standard. When the literal text cannot be applied to the product, such as for new materials or construction, and when a relevant CSA committee interpretation has not already been published, CSA Group’s procedures for interpretation shall be followed to determine the intended safety principle.”

Notes:

- 1) *Use of the singular does not exclude the plural (and vice versa) when the sense allows.*
 - 2) *Although the intended primary application of this Standard is stated in its Scope, it is important to note that it remains the responsibility of the users of the Standard to judge its suitability for their particular purpose.*
 - 3) *This Standard was developed by consensus, which is defined by CSA Policy governing standardization — Code of good practice for standardization as “substantial agreement. Consensus implies much more than a simple majority, but not necessarily unanimity”. It is consistent with this definition that a member may be included in the Technical Committee list and yet not be in full agreement with all clauses of this Standard.*

CSA C22.2 No. 232:22

Optical fiber cables

1 Scope

1.1

This Standard applies to non-conductive optical fiber cable and conductive optical fiber cable intended to be installed indoors in non-hazardous locations in accordance with CSA C22.1, *Canadian Electrical Code, Part I*.

This Standard provides performance requirements for products installed in accordance with Section 56 of the *Canadian Electrical Code, Part I*.

1.2

This Standard does not apply to hybrid optical fiber cables whose construction (excluding the optical fiber component) is covered in other applicable Standards of the *Canadian Electrical Code, Part II*.

1.3

The values given in SI units are the units of record for the purposes of this Standard. The values given in parentheses are for information and comparison only.

1.4

In this Standard, “shall” is used to express a requirement, i.e., a provision that the user is obliged to satisfy in order to comply with the Standard; “should” is used to express a recommendation or that which is advised but not required; and “may” is used to express an option or that which is permissible within the limits of the Standard.

Notes accompanying clauses do not include requirements or alternative requirements; the purpose of a note accompanying a clause is to separate from the text explanatory or informative material.

Notes to tables and figures are considered part of the table or figure and may be written as requirements.

Annexes are designated normative (mandatory) or informative (non-mandatory) to define their application.
