This is the second edition of CSA C22.2 No. 60335-2-9, *Household and similar electrical appliances — Safety — Part 2-9: Particular requirements for grills, toasters and similar portable cooking appliances*, which is an adoption, with Canadian deviations, of the identically titled IEC (International Electrotechnical Commission) Standard 60335-2-9 (seventh edition, 2019-05). It supersedes the previous edition published in 2014 as CAN/CSA-C22.2 60335-2-9 (adopted IEC 60335-2-9:2008+A1:2012). It is one in a series of Standards issued by CSA Group under Part II of the *Canadian Electrical Code*.

For brevity, this Standard will be referred to as “CSA C22.2 No. 60335-2-9” throughout.

This Standard is intended to be used in conjunction with CAN/CSA-C22.2 No. 60335-1:16, *Household and similar electrical appliances — Safety — Part 1: General requirements* (adopted IEC 60335-1:2010+ A1:2013, with Canadian deviations).

This Standard is considered suitable for use for conformity assessment within the stated scope of the Standard.

This Standard was reviewed for Canadian adoption by the CSA Technical Committee on Consumer and Commercial Products, under the jurisdiction of the CSA Strategic Steering Committee on Requirements for Electrical Safety, and has been formally approved by the Technical Committee.

This Standard has been developed in compliance with Standards Council of Canada requirements for National Standards of Canada. It has been published as a National Standard of Canada by CSA Group.

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-9: Particular requirements for grills, toasters and similar portable cooking appliances

1 Scope

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of electric **portable appliances** for household and similar purposes that have a cooking function such as baking, roasting and grilling, their **rated voltage** being not more than 250 V.

NOTE 101 Examples of appliances that are within the scope of this standard are

- **barbecues** for indoor use;
- **breadmakers**;
- **candy floss appliances**;
- **contact grills** (griddles);
- **cookers**;
- **food dehydrators**;
- **hotplates**;
- **induction wok hotplates**;
- **pop-corn makers**;
- **portable ovens**;
- **raclette grills**;
- **radiant grills**;
- **roasters**;
- **rotary grills**;
- **rotisseries**;
- **toasters**;
- **waffle irons**;

Examples are illustrated in Figure 101.

Appliances intended for normal household and similar use and that may also be used by laymen in shops, in light industry and on farms, are within the scope of this standard. However, if the appliance is intended to be used professionally to process food for commercial consumption, the appliance is not considered to be for household and similar use only.

As far as is practicable, this standard deals with the common hazards presented by appliances that are encountered by all persons in and around the home. However, in general, it does not take into account

- persons (including children) whose
 - physical, sensory or mental capabilities; or
 - lack of experience and knowledgeprevents them from using the appliance safely without supervision or instruction;
- children playing with the appliance.
