CSA Preface

This is the first edition of CSA C22.2 No. 63092-1, *Photovoltaics in buildings — Part 1: Requirements for building-integrated photovoltaic modules*, which is an adoption, with Canadian deviations, of the identically titled IEC (International Electrotechnical Commission) Standard 63092-1 (first edition, 2020-09). It is one in a series of Standards issued by CSA Group under Part 1 of the *Canadian Electrical Code*.

For brevity, this Standard will be referred to as “CSA C22.2 No. 63092-1” throughout.

This Standard is intended to be used in conjunction with CSA C22.2 No. 63092-2:24, *Photovoltaics in buildings — Part 2: Requirements for building-integrated photovoltaic systems* (adopted IEC 63092-2:2020, with Canadian deviations).

This Standard is considered suitable for use for conformity assessment within the stated scope of the Standard.

The Standard was reviewed for Canadian adoption by the CSA Subcommittee on Building-Integrated Photovoltaics, under the jurisdiction of the CSA Technical Committee on Solar Photovoltaic Energy Systems, the CSA Strategic Steering Committee on Requirements for Electrical Safety, and the CSA Strategic Steering Committee on Performance, Energy Efficiency, and Renewables, and has been formally approved by the Technical Committee.

This Standard has been developed in compliance with Standards Council of Canada requirements for National Standards of Canada. It has been published as a National Standard of Canada by CSA Group.

Interpretations: The Strategic Steering Committee on Requirements for Electrical Safety has provided the following direction for the interpretation of Standards under its jurisdiction: “The literal text shall be used in judging compliance of products with the safety requirements of this Standard. When the literal text cannot be applied to the product, such as for new materials or construction, and when a relevant CSA committee interpretation has not already been published, CSA Group’s procedures for interpretation shall be followed to determine the intended safety principle.”
