Preface

This is the twelfth edition of CSA C22.2 No. 96, *Portable power cables*, one of a series of Standards issued by CSA Group under the *Canadian Electrical Code, Part II*. It supersedes the previous editions, published in 2017, 2013, 2009, 2003, 1998, 1992, 1989, 1974, 1964, 1958, and 1951.

The following are major changes to this edition:

- a) the addition of a new Clause (Clause [16](#)) to cover special construction cable types SHD-SP, SHD-GC-SP, and SHD-BGC-SP, rated 2 kV up to 35 kV;
- b) clarifications of the weather resistance requirements; and
- c) updates to the cross-section drawings in Annex [B](#).

This Standard is considered suitable for use for conformity assessment within the stated scope of the Standard.

This Standard was prepared by the Subcommittee on Portable, Mine Power Feeder and Wind Turbine Cables, under the jurisdiction of the Technical Committee on Wiring Products and the Strategic Steering Committee on Requirements for Electrical Safety, and has been formally approved by the Technical Committee.

This Standard has been developed in compliance with Standards Council of Canada requirements for National Standards of Canada. It has been published as a National Standard of Canada by CSA Group.

Interpretations: The Strategic Steering Committee on Requirements for Electrical Safety has provided the following direction for the interpretation of standards under its jurisdiction: “The literal text shall be used in judging compliance of products with the safety requirements of this Standard. When the literal text cannot be applied to the product, such as for new materials up to 35 kV-rated round portable power cable with three insulated conductors, and when a relevant committee interpretation has not already been published, CSA Group’s procedures for interpretation shall be followed to determine the intended safety principle.”

Notes:

- 1) *Use of the singular does not exclude the plural (and vice versa) when the sense allows.*
- 2) *Although the intended primary application of this Standard is stated in its Scope, it is important to note that it remains the responsibility of the users of the Standard to judge its suitability for their particular purpose.*
- 3) *This Standard was developed by consensus, which is defined by CSA Policy governing standardization — Code of good practice for standardization as “substantial agreement. Consensus implies much more than a simple majority, but not necessarily unanimity”. It is consistent with this definition that a member may be included in the Technical Committee list and yet not be in full agreement with all clauses of this Standard.*
