This is the third edition of CSA Z1006, *Management of work in confined spaces*. It supersedes the previous editions published in 2016 and 2010.

Changes in this edition include

- a) improvement of the flow and readability of the document with the inclusion of additional flowcharts and tables and restructuring of content and clauses;
- b) harmonization of this Standard with CSA Z45001, CAN/CSA-Z1001, and CAN/CSA-Z1002;
- c) elaboration on the information regarding workspace design and modification; and
- d) elaboration on the information regarding monitoring confined space remotely through the use of technology.

CSA Group acknowledges that the development of this Standard was made possible, in part, by the financial support of federal, provincial, and territorial occupational health and safety government agencies.

This Standard was prepared by the Technical Committee on Management of Confined Space Entry, under the jurisdiction of the Strategic Steering Committee on Occupational Health and Safety, and has been formally approved by the Technical Committee.
