This is the fourth edition of CSA Z432, *Safeguarding of machinery*. It supersedes the previous editions published in 2016, 2004, and 1994.

This Standard specifies requirements for the design, manufacture (including remanufacture and rebuilding), installation, maintenance, operation, and safeguarding of industrial equipment to prevent injuries and accidents and enhance the safety of personnel who operate, assemble, and maintain machinery.

The major changes to this edition include the following:

- a) restructure flow of document to align with hierarchy of control;
- b) updates for continued alignment with applicable ISO standards and ANSI B11.19; and
- c) updates to Clause [6](#).

 - a) *define the problem, making reference to the specific clause, and, where appropriate, include an illustrative sketch;*
 - b) *provide an explanation of circumstances surrounding the actual field condition; and*
