0 Introduction

0.1 General

Environmental, health, and safety concerns are becoming increasingly important. Flaring, incineration, and enclosed combustion technology helps manage these issues.

0.2 Users

This Standard is intended to be used by

- a) manufacturers of flares, incinerators, and enclosed combustors;
- b) operators and users of flares, incinerators, and enclosed combustors;
- c) designers and integrators of flares, incinerators, and enclosed combustors;
- d) oil and gas regulators; and
- e) concerned stakeholders.

0.3 Application

This Standard applies to control devices (flares, incinerators, and enclosed combustors) and their associated equipment, which combust waste gas in the upstream oil and gas industry.

1 Scope

1.1 Applicability

1.1.1 Inclusions

This Standard applies to flares, incinerators, and enclosed combustors used in the following sectors:

- a) drilling operations;
- b) completions and well testing;
- c) well sites and gathering pipelines;
- d) thermal in-situ operations;
- e) process facilities (up to and ending at custody transfer at the product outlet point); and
- f) workovers and well servicing.

1.1.2 Exclusions

This Standard excludes the following sectors:

- a) transmission and distribution applications;
- b) oil sand mines;
- c) LNG plants;
- d) offshore applications; and
