Safety of primary batteries with aqueous electrolyte

Introduction

This Japanese Industrial Standard has been prepared based on **IEC 60086-5:2016**, Edition 4 with some modifications of the technical contents, made to reflect the local needs and situations in Japan.

The vertical lines on both sides and dotted underlines indicate changes from the corresponding International Standard. A list of modifications with the explanation is given in Annex JA.

1 Scope

This Standard specifies tests and requirements for primary batteries with aqueous electrolyte to ensure their safe operation under intended use and reasonable foreseeable misuse.

NOTE 1 Herein, the primary batteries with aqueous electrolyte refer to five battery systems shown in Table 1.

NOTE 2 Although this Standard specifies the safety of primary batteries with aqueous electrolyte, it is not, by itself, intended to be used for conformity assessment purposes.

NOTE 3 The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows.

IEC 60086-5:2016 *Primary batteries—Part 5: Safety of batteries with aqueous electrolyte* (MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standard and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to **ISO/IEC Guide 21-1**.
