Consequently, **JIS D 9115**:2013 is replaced with this Standard, and **JIS D 9207**:2000 has been withdrawn and replaced with this Standard.

Electric power assisted bicycles

Introduction

This Japanese Industrial Standard was established in 2009 and has gone through a revision in 2013 up to the present.

Today, electric power assisted bicycles vary in function, construction and performance across countries and regions. This Standard has been revised for the purpose of facilitating communication among all stakeholders related to electric power assisted bicycles by standardizing the safety requirements, test methods, design requirements, etc. in order to secure the safety and convenience of “electric power assisted bicycles” in Japan.

No corresponding International Standard has been established at this point.

1 Scope

This Standard specifies electric power assisted bicycles classified in Table 1 of **JIS D 9111**.
