This translation has been made based on the original Japanese Industrial Standard revised by the Minister of Economy, Trade and Industry, through deliberations at the Japanese Industrial Standards Committee as the result of proposal for revision of Japanese Industrial Standard submitted by The Japan Iron and Steel Federation (JISF) with the draft being attached, based on the provision of Article 12 Clause 1 of the Industrial Standardization Law applicable to the case of revision by the provision of Article 14.

Consequently **JIS G 3125: 2010** is replaced with this Standard.

However, **JIS G 3125: 2010** is applicable in the **JIS** mark certification based on the relevant provisions of Article 19 Clause 1, etc. of the Industrial Standardization Law until November 19, 2016.

Superior atmospheric corrosion resisting rolled steels

Introduction

This Japanese Industrial Standard has been prepared based on the fourth edition of **ISO 5952** published in 2011 with some modifications of the technical contents.

The portions given sidelines or dotted underlines are the matters in which the contents of the corresponding International Standard have been modified. A list of modifications with the explanations is given in Annex JA.

1 Scope

This Standard specifies the rolled steels having high atmospheric corrosion resistance (hereafter referred to as “rolled steels”) to be used for vehicles, buildings, steel towers and other structures.

NOTE 1 The term “atmospheric corrosion resistance” means the property to withstand the corrosion in the atmosphere.

NOTE 2 The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO 5952 : 2011 *Continuously hot-rolled steel sheet of structural quality with improved atmospheric corrosion resistance* (MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standard and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to **ISO/IEC Guide 21-1**.
