Introduction

This Japanese Industrial Standard has been prepared based on ISO 9328-1 : 2018, Edition 4, ISO 9328-3 : 2018, Edition 4, ISO 9328-5 : 2018, Edition 4 and ISO 9328-6 : 2018, Edition 3, with some modifications of the technical contents.

The vertical lines on both sides and dotted underlines indicate changes from the corresponding International Standards. A list of modifications with the explanations is given in Annex JA.

1 Scope

This Standard specifies requirements for the hot-rolled carbon steel plates (hereafter referred to as steel plates) used for pressure vessels and pressure equipment for low temperature service.

NOTE The International Standards corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO 9328-1 : 2018 *Steel flat products for pressure purposes — Technical delivery conditions — Part 1 : General requirements*

ISO 9328-5 : 2018 *Steel flat products for pressure purposes — Technical delivery conditions — Part 5 : Weldable fine grain steels, thermo-mechanically rolled*

ISO 9328-6 : 2018 *Steel flat products for pressure purposes — Technical delivery conditions — Part 6 : Weldable fine grain steels, quenched and tempered (overall evaluation : MOD)*

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standards and JIS are IDT (identical), MOD (modified), and NEQ (not equivalent) according to ISO/IEC Guide 21-1.
