Introduction

This Japanese Industrial Standard has been prepared based on ISO 11950 : 2016, Edition 2, with some modifications of the technical contents.

The vertical lines on both sides and dotted underlines indicate changes from the corresponding International Standard. A list of modifications with the explanations is given in Annex JA.

1 Scope

This Standard specifies requirements for chromium coated tin free steel mainly intended for beverage cans or food cans.

NOTE The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO 11950 : 2016 *Cold-reduced tinmill products — Electrolytic chromium/chromium oxide-coated steel (MOD)*

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standard and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to ISO/IEC Guide 21-1.
