# Plastics—Unplasticized poly (vinyl chloride) sheets

## Introduction

This Japanese Industrial Standard has been prepared based on the third edition of **ISO 11833-1** published in 2012 with some modifications of the technical contents.

The portions given sidelines or dotted underlines are the matters in which the contents of the corresponding International Standard have been modified. A list of modifications with the explanations is given in Annex JC.

## 1 Scope

This Standard specifies the requirements for flat extruded sheets and pressed sheets of unplasticized poly (vinyl chloride) (hereafter referred to as “sheets”). It applies only to sheets of thickness not less than 1.0 mm. It does not cover biaxially stretched poly (vinyl chloride) sheets and embossed sheets.

NOTE : The International Standard corresponding to this standard and the symbol of degree of correspondence are as follows.

ISO 11833-1:2012 *Plastics—Unplasticized poly (vinyl chloride) sheets—Types, dimensions and characteristics—Part 1: Sheets of thickness not less than 1 mm* (MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standard and **JIS** are **IDT** (identical), **MOD** (modified), and **NEQ** (not equivalent) according to **ISO/IEC Guide 21-1**.
