Introduction

This Standard complements the requirements specified in JIS Q 17021-10:2018, pertaining to competencies of personnel providing audit and certification of JIS Q 45100:2018. JIS Q 45100:2018, applied in combination with JIS Q 45001:2018, is provided with the objectives of conforming to Japanese laws and regulations, incorporating specific health and safety activities and initiatives of ensuring health which have been introduced by many Japanese companies, and constructing an effective occupational health and safety (OH&S) management system to prevent work-related injury and to ensure health of workers.

This Standard is intended to clarify the competence requirements for personnel providing audit and certification specified in JIS Q 45100:2018.

This Standard incorporates requirements of JIS Q 17021-10 without change and provides additional specifications on requirements and notes, which are additionally specified in JIS Q 45100:2018, for bodies providing audit and certification of specific health and safety activities and health and safety administration at Japanese companies. Such additional information is represented in italic and bold letters.

1 Scope

This Standard specifies competence requirements for personnel involved in the audit and certification process of JIS Q 45100:2018.
