Introduction

This Japanese Industrial Standard has been prepared based on the first edition of IEC 60601-2-52 published in 2009 and Amendment 1 : 2015 with some modifications of the technical contents to enhance safety requirements for preventing accidents around bed rails. The amendment to the said International Standard has been compiled in this Standard.

The vertical lines on both sides of the text and dotted underlines indicate changes from the corresponding International Standard. A list of modifications with the explanations is given in Annex JA.

1 Scope

This Standard specifies the manually and electrically operated nursing beds principally intended for use in medical facilities (hereafter referred to as beds) that are capable of stepless adjustment of the angle of the back and leg sections, platform height and/or inclination of the whole bottom. This Standard is also applicable to the flat floor type beds without the adjustment mechanism. It is not applicable to the beds for medical care, the beds for children, the beds for a particular function and the electrically operated adjustable beds for home use.

NOTE 1 The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows.

IEC 60601-2-52 : 2009 *Medical electrical equipment — Part 2-52 : Particular requirements for the basic safety and essential performance of medical beds* and Amendment 1 : 2015 (MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standard and JIS are IDT (identical), MOD (modified), and NEQ (not equivalent) according to ISO/IEC Guide 21-1.

NOTE 2 The beds for a particular function refer to those beds with other function (such as rolling function and delivery table function) than the function of manual or mechanical stepless adjustment of the angle of the back and leg sections and/or platform height.

NOTE 3 The beds for medical care refer to those beds that are registered as medical devices in accordance with the Act on Pharmaceuticals and Medical Devices.
