1 Scope

This standard is intended to present in concise and convenient form all standards for electrical insulating varnishes.

It includes definitions, instructions, and methods for determining the mechanical, thermal, and electrical performance characteristics of electrical insulating varnishes and specifications.

The intent of this standard is to supersede MIL-I-24092D. See Table 1-1 for cross-reference to mil-spec classifications.
