Foreword

This standard provides basic requirements for best practices for the application of industrial/marine protective coatings to coated or uncoated metallic substrates and is intended for use by both specifiers and contractors, either in its entirety or by referencing specific sections. It focuses on the coating application process and application-related items that are included as one element of the contractor's work plan or process control procedures.

Scope

The scope of this standard includes specific as well as general requirements for the application of liquid coatings applied by brush, spray, or roller. Detailed descriptions of site preparation, surface preparation, pretreatments, or selection of primers and finish coats are beyond the scope of this standard.

Rationale

This revision is the result of the required periodic review of AMPP standards and includes minor revisions to the 2016 version of this standard.
